The purpose of this letter is to provide you with details of particular concerns that have been brought up by the crew members. This letter will provide you with a breakdown of the items of concern.

**C.B.A**Section 8 Scheduling: E2-Roster Administration

Schedulers are not mentioning the word "Crew-Call" when leaving voicemails or messages with persons other than the crew member. This matter is currently the subject of an ongoing dispute with the OPS.

Section 8 Scheduling: E11-Trip Trade/Swaps

The Company, to date, currently does not have the functionality of "Trip Trade/Swaps" availability to the crew, this matter is pending F.M.C.S. arbitration.

**L.O.U. (Crewmember Remote Internet Access to Duty Changes and Crew Scheduling Committee)**(Page 2, Paragraph 3)

Company is not sending text messages for "Duty Changes" (flights changed to reserve, trip changes, etc.)

(Page 2, Paragraph 3)

Company is not sending text messages for "Departure time changes greater than 30 minutes"

(Page 2, Paragraph 5)

Company has not issued any of the required "Reports" to the Scheduling Committee. The Union did properly notify the Company of who is on the scheduling committee, from our understanding, Miami is unaware of who is on the "Scheduling Committee".
