All full-time and regular part time drivers, including delivery drivers, export/cruise drivers, fresh drivers, hot shot drivers, and shuttle drivers, employed by the Employer at its facilities in Medley, Auburndale and Key West, Florida, who were employed by the Employer during the payroll period ending January 26, 2019.
