The Local Union will receive, by separate fax, a "VOTING CREDENTIALS REQUEST FORM" which must be completed for every eligible member requesting Voting Credentials. The Local will handle any request from members, confirm that the individual is an eligible voter, and forward the form to the IBT Airline Division at (202) 624-7494. PHONE OR EMAIL REQUESTS WILL NOT BE ACCEPTED. (Again, the Form will be faxed separately.)
